**All booths are available on a first come, first serve basis. Spaces are limited, so don't delay!
We're looking forward to another amazing year and can't wait to see you there!
Hours of Operation: Saturday 9am – 7pm & Sunday, 9am – 4pm.**

- High touch surfaces must be continually sanitized in accordance with CDC guidelines. You must provide your own cleaners, masks and sanitizer.
- This is an outdoor event. We provide space only; you must provide the materials (shading/canopies) and the personnel needed for your booth. No electricity is provided. Generators can be used.
- **Per the City Park regulations, booths are not allowed to be staked into the ground, please bring weights to attach to your booth.**
- All booth fees are final, there will be **no refunds** due to acts of nature or unforeseen situations or circumstances.
- Setup and check in times: Check in starts at 12:00 p.m. Friday, May 3rd until 5:00 p.m. for all regular booth vendors. **FOOD VENDORS** check in from 9:00 a.m. until 12:00 p.m. on Friday.
Regular booth check-in will resume on Saturday, May 4th at 7:00 a.m.
- All vendors must be open for business on Saturday by 9 a.m.
- **THERE IS NO PARKING IN VETERANS PARK** except for handicap parking! Cars without proper verification will be towed.
- Hours of operation: Saturday from 9 a.m. until 7 p.m. Sunday from 9 a.m. until 4 p.m. Early breakdown is permitted on Sunday after 2 p.m. only. If you choose to breakdown early, your final paperwork and deposit refund is subject to the availability of the Craft Fair Coordinator or their representative.
- Sales Tax/Security: A separate check in the amount of \$50.00 is required as a deposit for your sales tax and space. Once you've turned in your tax form and completed the check-out process, your check will be returned to you. Failure to comply with the check-out process will result in the forfeiture of your deposit check.
- There will be 24-hr security beginning at noon on Friday through closing on Sunday.

Check List that is due to us by April 10th 2024:

1. \$50.00 Sales tax and security Deposit (**Check only**)
2. Copy of your Sales Tax License (if applicable)
****Please Note:** If you are not a food vendor, you **do not** need a sales tax or special event license - we will collect the taxes from you on the last day and submit them to the State of Colorado on your behalf.
3. Completed and Signed Good Faith Waiver form.
4. If Non-Profit, a copy of 501-C3 Status.
5. **FOOD VENDORS ONLY:** Copy of Limited Liability Insurance.
